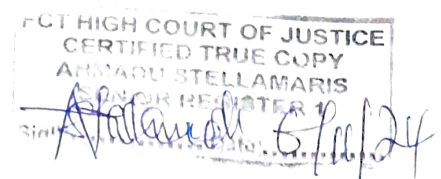

COURT ORDER

2. **AN ORDER** of this Honourable Court, directing the Inspector-General of Police, whether by himself or through the Officers of the Nigeria Police Force, to ensure compliance with the Order of Court by arresting the Judgment Debtor/Contemnor and handing him over to the Officers of the Nigerian Correctional Service, Kuje
3. **AND FOR SUCH FURTHER OR OTHERS ORDERS** as this Honourable Court may deem fit to make in the circumstance.

Upon further reading of the 5 paragraphs affidavit in support of the Motion sworn to by **KAYODE SHADE**

And upon further hearing of **ADEWALE ADEGBOYEGA** Counsel for the Judgment Creditor.

**IT IS HEREBY ORDERED AS FOLLOWS:**

Having perused the processes filed in connection with Motion on Notice No: M/13706/2024 filed by the Judgment Creditor on 17/10/2024. And also having considered the facts deposed to in the
